

7.1 Ruggedness in class-AB operation

The BLP15H9S30G is capable of withstanding a load mismatch corresponding to VSWR = 30 : 1 through all phases under the following conditions: $V_{DS} = 55$ V; $I_{Dq} = 10$ mA; $P_L = 47$ W; f = 1400 MHz; pulsed CW ($t_p = 100 \ \mu$ s; $\delta = 20 \ \%$).









7.3.1 Pulsed CW performance measured in production RF test circuit




