

7.1 Ruggedness in class-AB operation

The BLP15H9S100G is capable of withstanding a load mismatch corresponding to VSWR = 30 : 1 through all phases under the following conditions: V_{DS} = 55 V; I_{Dg} = 30 mA; P_L = 120 W; f = 1400 MHz; pulsed CW (t_p = 100 µs; δ = 20 %).


